### Egypt General Organization for Export & Import Control

GENERAL ORGANIZATION FOR EXPORT & IMPORT CONTROL (GOEIC) has appointed Baltic Control® for verification of the conformity of products before shipment to Egypt.

Baltic Control® has been accredited since October 2024.

#### OBJECTIVES:

1. Consumer and environment protection, support for Egyptian industries.
2. Conformity and quality assurance of the goods imported.
3. Faster release of goods at Arab Republic of Egypt Customs offices at the borders and the entry points.

#### PROCESSING OF DOCUMENTS:

The exporter lodges a request for verification via the Baltic Control® offices according to the contact details stated later in this document. This request should include:

- Declaration of registration at GOEIC – all exporters of regulated products must register with GOEIC to export to Egypt.
- Proforma invoice / final invoice / packing list / name and contact info of the importer and exporter.
- Conformity documents or test reports (issued by ISO 17025 accredited laboratory) that comply with the Egyptian standards.
- Certificates related to the management of quality / safety system.
- Information related to the location and provisional date for

#### BALTIC CONTROL® VERIFICATION PROCESS

1. Baltic Control® reviews the information and the documents provided.
2. Contact the customers to coordinate with them regarding physical inspection. If necessary, samples are taken, and laboratory testing/analysis is carried out in accredited labs.
3. Baltic Control® verifies consistency and accuracy of data collected during the verification process. Upon satisfactory result and receipt of the final invoice and a transport document, a secured Certificate of Conformity (COC) is prepared, which is accepted by customs employees at the Egyptian border and the entry points.
