

PRE-SHIPMENT AND BORDER INSPECTION Pakistan

MINFA

Baltic Control[®] is on the panel of Pre-shipment Inspection Agencies of the Department of Plant Protection under the Ministry of National Food Security and Research of the Government of Pakistan. This approval allows Baltic Control[®] to issue inspection certificates required for the export of pesticides, insecticides, fungicides, rodenticides to Pakistan. Through our worldwide network these services are available on a global basis. This service is provided to exporters as well as to the importers depending on contractual terms and conditions between the parties involved.

Objectives

Shipments conform to importing standards in order to be cleared at destination.

Process

The exporter/importer lodges a request for certificate with the Baltic Control® offices with the below information:

- Valid registration certificate issued by Department of Plant Protection for the specific product being imported/ inspected
- Invoice/or proforma invoice, packing list with the name of the product and batch numbers
- Port of arrival, buyer details
- Internal analysis report
- MSDS
- Information related to the location and provisional date for the goods for the performance of physical and loading inspection
- Bill of Lading, Letter of Credit, Goods Declaration (GD)

Baltic Control® Team Mission

- 1. Baltic Control[®] reviews the information and the documents provided
- 2. Contact the exporter to coordinate sampling if required
- 3. Send samples to ISO 17025 accredited laboratory for testing as per appointed standard if required
- 4. Baltic Control[®] verifies the results from the test reports, once analyses confirms cargo is in accordance with registered specifications, pre-shipment and loading inspection is arranged
- 5. Final Inspection Certificate is prepared, which is accepted by customs authorities

Verification at destination

Verification will be performed at destination by the custom authorities when the goods reach the Pakistan border and the entry points. The custom authorities release a consignment on Pre-shipment Inspection Reports only after the endorsement by the Department of Plant Protection, to ensure these reports authenticated. Department of Plant Protection will obtain 10% random sample of pesticides at the time of arrival for reanalysis in Federal Pesticides Testing & Reference Laboratory Karachi in order to ensure the quality and Vigilance.
