Important!

- The supplier needs to ensure that the cargo is 100% ready for the verification – packed with access to perform the visual verification.
- In order to arrange verification in due time, we need to receive the Request for Verification (RFV) within 3 working days prior to planned verification.
- If goods are to be presented for verification in partial shipments, Baltic Control A/S has to be informed prior to verification.
- Should there be any changes or delays in the original verification schedule, Baltic Control A/S has to be notified at least 24hrs prior to verification. Otherwise the abortive verification costs will be charged to your account.
- Inspector is to have free access including but not limited to the cargo. Supplier is obliged to make all necessary arrangements for verification i.e. ensure proper space, provide man power in order to move packing units, handle verified items, spread out the articles, if necessary and re-pack after verification.
